

With May arriving, many of our WWW members, like so many other seasonal residents of Fairway Village, have departed to northern summer residences. As many residents leave, our neighborhoods become very quiet and those who live alone may feel a bit isolated. This is a

good time to remind everyone that the American Red Cross provides a **FREE** service called, the Telephone Reassurance Program. Volunteers make daily phone calls seven days a week in the morning to check on those who sign up for the service. If they do not get an answer, a volunteer or a contact person of your choosing, will be dispatched to your home to check on your well-being.

Those who sign up for the service must be home during the designated morning time frame for the calls. If you cannot be home on a particular morning or plan to be away on vacation, you can notify your volunteer caller the day before to stop the calls for that time period. We hope those living alone in neighborhoods which empty out in the summer months will consider







Remembering Our Past

– The original land was 135 acres of pasture, brush trees and marshes. It was purchased by Harold Neal, an attorney, and 22 other investors from Michigan. One of the investors, Charles Rahfeld, was the residential manager and on-site developer. The original name, Fairway Village, and golf terminology for the streets was established.

– Fairway Village was officially opened in January. The first building constructed was on Lot 56. This was the location of the first sales office. The first resident was Ross Neal on Lot 72. Fifty homes were completed and occupied. The golf course, original clubhouse and North swimming pool were completed. Chuck Knight, who got the first hole-in-one on February 16, still resides in the Village with his wife Cis.

– Originally, the post office stated that mail would be dispersed at several local mail centers within the village. Harold Neal objected strongly and held out for house-to-house delivery. Final approval came as a result of his efforts and the trip he made to Washington, D. C. Beatrice Foods purchased Fairway Village and William Jacobsen Mfg. Co. They purchased several other mobile home parks in Pinellas County.

1973 – Beatrice Foods sold Fairway Village and the Jacobsen Mfg. back to William Jacobsen.

– The first phone book for Fairway Village was published. Jacobsen enlarged the clubhouse. Maintenance fee was \$45.00 per month.

– William Jacobsen sold Fairway Village to John Ericksen, owner of Florida Leisure Communities for \$5,216,400.

1976 – The first big band to play in Fairway Village was Sammy Kaye.

– Belcher Road was widened from 2 to 6 lanes and hard surfaces. The first Fairway Village Flier was published in March. An Ad Hoc committee was formed for the purpose of buying Fairway Village if it went on the market. John Stecher and Mel Harms headed this committee.

– The South pool was completed. The last home in Fairway Village was built on Lot 384, filling all 751 lots.

– Kitchen and clubhouse were enlarged and improved. George McGough, a resident, was elected mayor of Largo.

1983 – Florida Leisure announced it was going to sell all their parks by 1985.

1984 – Signal light at the entrance to Fairway Village on Belcher Road was installed in August. At a meeting on March 17, 90% of the residents voted to buy Fairway Village. In order to meet the down payment, each lot owner paid \$5,900. On December 26, the residents purchased Fairway Village for \$12,687,000. If Fairway Village had not been sold by January1, 1985, the maintenance fee would have been \$185 per month. The first pictorial directory for Fairway Village was produced.

1994 – Loan from First Union Bank completely paid on July 19.

1995 – A big party and mortgage burning was held in Fairway Village on January 7.

2002 – As of January, three of the original fifty 1971 lot owners still reside in Fairway Village.

2005 – Since the original 751 homes were completed in 1979, 46 replacements have been made with new homes. Of these 46, 18 have been built since 2002. We've had a change of ownership at 328 locations since 2000, either by death or moving.

Major Village Improvements

New roofs on the clubhouse and maintenance buildings. An improvement of the clubhouse air conditioning system. An update of the audio and speaker system in the clubhouse. The replacement of storm runoff conduits in seven locations. The construction of a wooden fence on most of the perimeter. Thermal underground heating system were installed in both pool sites.

Architectural Review Committee

The ARC Policies and Procedures Manual defines and outlines the guidelines for all exterior changes to homes, as well as, for replacing homes. This manual is available from the office or may be downloaded from the FVRA website (Fairway Info; Home Buyers information, ARC revised P and P). Before you begin your project please obtain a Home replacement or Modification Request form from the FVRA



office or download it (page 12, Exhibit D, in the manual) and return the completed form to the FVRA office. The ARC, which meets most Mondays in the Clubhouse, looks forward to working with you in replacing your home or planning the changes to the outside of your home.






