

In May, the LH Board met twice with our attorney in order to clarify qualified residency within our community. It is the fiduciary responsibility of the board to serve and represent all residents and in doing so to carry out those duties in such a way as to keep the residents' best interest in mind. clarification may be needed within the documents. The following is what we have learned is permissible by the association as a result of our current Lake Highlander governing documents, rules and regulations, established procedures, and Florida Statues.

- 1. An owner must submit a written request to the Board of Directors for consideration of any situation allowing someone other than the current owner(s) to reside in the home beyond the permissible "guest" allotted time frame.
- 2. Anyone seeking to be a resident within the Lake Highlander community, no matter the age of the individual, family member or not, certificate holder or not will be required to have a background and credit check prior to board consideration of the request. Current unit owners have been required to do this, which provides a level of security to all residents; therefore, anyone who will be under consideration as a permanent or a temporary resident must follow the same procedure.
- 3. Additionally, if a resident is asking to have a care giver reside with him/her (family member or not), a doctor's letter will be required supporting the reason for this need and the estimated time frame involved for this need. This information will be required whether the request is for a second or a third person to reside in the unit.

Our governing documents and Rules and Regulations are in place in order to keep our community safe and to provide consistent management. Further discussion will be had on this matter in the fall, but for now I wanted to share with you what the board has learned and the procedures management will follow.



ertainly my 37 years in the Army and our many moves in Canada after we married plus three tours of Germany for total of seven years over the period 1966-1996 played a significant part in our wanting to explore the world. We have visited most NW Europe countries and many others including parts of Norway, Sweden, Russia, Greenland, Australia, Africa, Mexico, Columbia South America, & most Caribbean Islands. Also, we travelled to much of the USA including a five week road trip by car in 2014 from Dunedin to California and back exploring Louisiana, Texas, New Mexico, Arizona, & California. All of this to say Dianne and I (lot 49) love to travel and explore.

While we have enjoyed every trip, in September 2017 we went on a unique three-week trip of a lifetime to China, a country of 1.4 billion people. The incredible trip was superbly organized by a Canadian company called Sinorama. All expenses like a full- time guide(s), 8 flights, 4-day river cruise on Yangtze River, entertainment, meals, 5 star hotels, taxes, cancellation fee of \$500 and tips were included in the upfront costs: \$8,000 CDN for two people! It is believed the Chinese Government subsidizes these China tours.

Our trip began with a flight from Ottawa to Vancouver and then a 15-hour flight to Beijing where we were met by a guide and taken to our hotel. In Beijing, we toured the Great Wall, Tiananmen Square, Forbidden City, Temple of Heaven, an old city tour on a Rickshaw & a nighttime musical/dinner theatre. We then flew on a new 737 to Xi'an where we visited the famous excavation of the 8,000 Terra Cotta Warriors. We had a total of 4 internal flights on new aircraft where full hot meals were served even on two- hour flights. The flight attendants were immaculately dressed in uniforms like ours did in the 1950s. Another highlight of the tour was our 4-day cruise on the Yangtze River.

The river cruise was the most restful part of the tour although we stopped every day to

visit local towns & villages to learn about their distinctive cultures. Food throughout was plentiful and every breakfast was a Canadian style buffet all you could eat. Lunch and dinner was served on a lazy-Susan and always included soup, chicken, pork, beef and fish cooked in accordance with the local custom, but always good. We found the Chinese people were very friendly, warm and humble. We never felt unsafe even when looking for an ice cream at 10 PM in Wuhan... found 2 Haagen Daag bars for \$3! We experienced every form of transportation: planes, buses, river boat, bulletin train @ 100 MPH, rickshaw, sampan, and hydrofoil ferry.

Shanghai and Hong Kong were two major highlights. Our group consisted of 24 and all thoroughly enjoy our trip of a lifetime and would recommend it to all. Try it you'll love it

#### LHRO BOARD MEETING, JUNE 14, 2018

The following are unofficial notes of the June 14 board meeting:

- All board members were present, with Susan Zerbe and Gerry Killham participating by phone call.
- Karen Larrimore, acting president, called the meeting to order at 10:30 a.m. Steve Schultz led the Pledge of Allegiance. Karen then called for a moment of silent reflection.
- Karen read a statement written by President Zerbe regarding rules for residency within our Lake Highlander community. The text can be found in the President's Message in this issue of the Piper.
- Time for an open forum was provided. Jan Schultz asked if there were similar background and credit checks given for renters. Manager Beth Carroll responded that the owner renting out his or her coach must give that information to the park office. If you rent out your home, you must pay the county a tourist tax. The park does not want to become involved with any aspect of the rental as then we would be responsible for the tourist tax. Karen counseled that all owners must know the rules and regulations of the park. Susan further counseled that the board must look at this closely. Many times, a coach is rented out and the office is not informed of it.
- The minutes of the last meeting were approved.
- Manager's Report: The perimeter fence has been completed with no additional outlay of the maximum \$110,000. Beth thanked J. P. St. Laurent for his work in overseeing the project. Michael, our maintenance staff, has finished his certificate in Green Industry Best Management Practices. This allows him to maintain the grounds in our park without being fined. The laundry room pipes have been replaced and Michael was putting the room back together as we were meeting. The tile wall in the laundry room has been replaced with a plastic board which is screwed in, making easier access for additional pipe work in the future. The handrail at the pool is loose caused by cracked concrete at its underwater base. The pool will need to be drained for the repair work ASAP which will mean a pool closure of 3-4 days. A double railing may possibly be installed to replace the single railing. In the next couple of days concrete will be poured for the three additional gliders. The board agreed to also replace the four white, wooden, stationary benches with cedar benches. Benches and gliders will be available to be donated in memory of a loved one. Contact the office for more information. The chairs in the lanai need to be replaced due to snapping and cracking of the woven covers. The current chairs were purchased at Leaders but are not made anymore and Leaders will not reweave them. Karen and Beth looked at chairs at Rain Thatch in Clearwater. They are sturdy iron-framed chairs with a fabric sling-back cover. They have a 15-year warranty on the structure and wear & tear. Rain Thatch will repair them while under warranty for \$100 each. The cost is \$3,145.00 to replace the 12 chairs in the lanai. Current chairs will be sold. Contact the office if you would like to buy one. Motion to purchase the chairs was approved by the board.
- Treasurer's Report: Kathy Hartwell apologized for not having slides available as she is *continued on page 30*



still learning the technology. A discussion was held about possibly moving our assets to another bank, but this idea was shelved. Kathy proposed we stay with our current bank as at this time there are no fees.

- There were no standing reports.
- Unfinished business: Fred Wimmer presented a report about backup generators. He proposed buying backup generators for the office and the multi-purpose building. The office generator is needed because the office is the hub for running the park and backup power is needed in the event of a power outage. The multi-purpose building was selected to benefit the park residents rather than the clubhouse. The multi-purpose building has building plans, but the clubhouse does not. The cost needed to change the structure of the clubhouse to accept a generator would exceed \$500,000. Fred moved that the board authorize Beth Carroll to purchase a backup generator for the office from Zabatt for a total cost of \$18,000. It was approved unanimously. Next, Fred moved that the board authorize Beth Carroll to purchase a backup generator for the multi-purpose building from Zabatt for a total cost of \$18,000. Again, this was approved unanimously. Beth stressed the need for creating policies regarding usage of the multi-purpose building by residents in the event of a power outage.
- New business: Warren Bowman mentioned that last Saturday a resident reported his coach was without water. Warren discovered that someone had shut off the main water valve that provides water to four coaches. Warren asked that a paper be prepared which provides contact information for issues such as this that occur when there is no staff working. Beth will move forward on this. The paper will also include what is each resident's responsibility versus the responsibility of Lake Highlander.
- The meeting was adjourned at noon.

#### THE TRUE STORY OF WINNIE-THE-POOH

hen Steve and I were recently driving on the Trans-Canada Highway along the shores of Lake Superior, we came to the small town of White River, population about 600. Along the highway is a park with a statue of Winnie-the-Pooh. You may not know that Winnie originated from here over 100 years ago.

Back then, there was no highway. Train travel was the vital method of transportation in the region and White River was an important stopping point for coal and water, often stopping for four to six hours.

In 1914, troops were headed on trains for Quebec and then to England for participation in WWI. A veterinarian, Lt. Harry Colebourn, was in-charge of the horses on the troop train. When the train stopped in White River, Lt. Colebourn purchased a bear cub for \$20 from a trapper. Since

the lieutenant hailed from Winnipeg, he named the black, female cub Winnipeg or "Winnie."

Once in England, Lt. Colebourn, now a Captain, could not care for Winnie when he received word he was being shipped to France. He arranged with the London Zoo to care for him. Captain Colebourn visited him whenever he was on leave.

Winnie became popular with children and adults who visited the zoo. After the war, Captain Colebourn decided not to take Winnie back to Canada with him. Winnie was donated permanently to the London Zoo in 1918.

One of the frequent visitors to the zoo was A. A. Milne and his son Christopher Robin Milne. One source says it was Christopher who added "Pooh" to Winnie's name. Other sources say the story of Winnie and Milne's story of a swan named Pooh were combined. When Christopher was given a stuffed bear for his birthday in 1921, he named it Winniethe-Pooh. His father soon began writing stories about the adventures of Winnie-the-Pooh. Winnie lived a full life at the zoo and died in 1934 at the age of 20.

So now you know the real story of Winnie-the-Pooh.
